- Magnetic Particle (MT)


- Liquid Penetrant (PT)

Health Benefits Plan

Providing health and wellness benefits are important to the well being and retention of your employees. Signatory contractors remit contributions based on worked hours. The NDT Industry Health Benefit Plan is self administered. This provides direct savings for our signatory contractors. There is also an opportunity for our signatory contractors to belong to the Health Benefit Plan as associate members.

Some highlights of the Benefits plan are:

Dental coverage paid at 100% for basic and major treatment. 75% **Orthodontic for dependant children. Extended Health Benefits** cover 90% of prescriptions cost. The plan covers 90% of **vision care** up to \$525 for employee/spouse and \$375 for dependant children, as well as maximums of \$500 for **massage**, **chiropractic**, **osteopath**, **naturopath**. Charges for **speech therapy**, **physiotherapy**, and services from a **registered psychologist** have no annual limit.

Group life insurance of \$100,000 and Long-Term disability benefits.

Wage Indemnity benefit covers non-WCB injuries for a maximum of 52 weeks with payments matching unemployment benefits or \$750 per week, whichever is greater.

Employee and Family Assistance Program, and Substance Abuse Rehabilitation Assistance.

Pension Plan

The NDT Industry Pension Plan administered by DA Townley. Employers contribute to the plan on behalf of their employees.


Our pension plan provides several benefits for our signatory contractors:

- Maintain productivity: A pension plan is a promise of better financial health for employees and their families during retirement.
- Foster retention and attraction of employees: A pension plan is a significant part of the employees' total compensation. It results in greater employee commitment and satisfaction. More evidence suggests that potential employees are interested in their long-term financial health and want pension plans.
- Maximize tax-effectiveness of compensation: An employer who grants a wage increase to employees must always consider the payroll taxes that will be payable on that increase. In a taxoptimized pension plan, the employer will not be subject to the payroll taxes on contributions made to employees.

Training Fund

The Training Fund promotes furthering education and career growth of all QCC Members. Signatory contractors contribute to the funds based on hours worked by employees. Eligible members are covered for all training related expenses including course fees, exam center fees, registration fees for initial and renewal/re-certification, LOA, and travel.

In a world where employees stay on average 3 years with one employer, it can be difficult to spend resources on training and retention. Our training funds offer a way to offset this by allowing companies to contribute per hour worked only, lowering risk to any one employer. By removing cost barriers to employees, our training fund offers a way to have more highly trained personnel with less financial burden for our contractors. A well-trained workforce will remain more motivated and productive and offer valuable mentorship opportunities to new recruits and trainees.
